INTRODUCTION

College Credit Plus (CCP) is Ohio's official dual credit program – a program that enables <u>college</u> <u>ready</u> students in grades 7-12 to take college courses for which they may earn both high school and college credit.

Effective dual credit systems have been linked to positive student impacts at both secondary and postsecondary levels. In addition, these programs have the capacity to create systemic collaboration, which will be necessary in order for Ohio to meet its college- and careerready, and postsecondary completion goals. These programs also have the added benefit of creating a reliable and seamless bridge for students to transition from high school into postsecondary endeavors. ~ Chancellor John Carey, Ohio Department of Higher Education

CCP Objectives

- to bolster college readiness
- to increase college persistence and completion
- to decrease the time needed to earn a college degree
- to decrease the overall cost of a college degree

What is the key difference between CCP and other advanced standing programs?

Transcripted Credit. Unlike Advanced Placement, International Baccalaureate and various 'articulated' programs, classes completed by CCP students are immediately recorded on an official college transcript. No intermediary steps are required.

All classes completed under the auspices of UC Clermont's CCP program are recorded immediately and permanently on a *University of Cincinnati* transcript!

CCP Guidelines: OHIO DEPARTMENT OF HIGHER EDUCATION (ODHE)

The Ohio Department of Higher Education (ODHE) has developed specific guidelines that CCP participants and administrators must follow. A few of these guidelines are detailed below.

Information and Counseling

- High schools must provide information about CCP to their students in grades six, seven, eight, nine, ten, and eleven. This information must include a detailed overview of the benefits and risks associated with CCP.
- By April 1, students must inform their high school of their 'intent to participate' in CCP. Students may change their minds at any time.

Both **public** and **nonpublic** secondary schools must permit eligible students to participate in the College Credit Plus program.

Enrollment Options

Students participating in CCP may pursue one of two enrollment options:

CCP Option A	CCP Option B
Eligible students may enroll in college courses for <u>either</u> college credit only <u>or</u> high school and college credit.*	Eligible students must enroll in college courses for <u>both</u> college <u>and</u> high school credit.
Students must pay for all of the costs associated with their college enrollment, including tuition/fees, books, and supplies.	The school district must pay for the cost of tuition and textbooks. The college must pay for the cost of <u>approved</u> supplies.

*Students must make this determination at the time of enrollment not after.

CCP students may take classes from multiple colleges concurrently.

Non-Public School Participation (Homeschool and Private High Schools)

Homeschoolers and students from non-public high schools may participate in CCP.

Credit Hour Equivalencies

According to CCP guidelines, a college course transcripting three (3) or more semester hours must count as one full Carnegie unit of credit at the high school. A college course transcripting less than three (3) semester hours must count as a proportional fraction of a Carnegie unit.

3+ Semester Hours (1 college course) = 1 Carnegie Unit (1 year of the subject at the high school)

Credit Hour Maximums

CCP participants may take up to **30 credit hours per academic year** for a maximum of 120 credit hours over the equivalent of four academic years.

As the following table indicates, the number of semester hours per year a student may take at UC Clermont is a function of the number of Carnegie units (CUs) a student plans to take at the high school.

Warning: It could be academically risky to pursue any of the Carnegie Unit / semester hour combinations noted in the 'gray zone'. Before doing so, students should discuss the benefits and risks with their high school guidance counselor.

Grade 'Weighting' (school district)

If a school district awards 'weighted' grades to students taking honors or advanced placement courses, it must do the same for students taking college courses under the auspices of CCP.

The policy for the awarding of grades and the calculation of class standing for CCP courses...shall not disadvantage students who choose to participate in CCP rather than other advanced standing programs, including advanced placement and international baccalaureate. ~Ohio Department of Higher Education

End-of-Course Exams (high school)

Grades earned at the college-level for American History, American Government, Biology and Physical Science classes will substitute for end-of-course exams. For more information, students should contact their high school guidance counselor.

CCP BENEFITS and RISKS

The College Credit Plus (CCP) program offers many academic and financial benefits as well as risks. A few of these benefits and risks are listed below.

Risks

- Students could experience a degree of academic difficulty that exceeds the level to which they are accustomed at their middle or high schools. They may also experience 'mature' classroom discussions and topics that some might consider inappropriate for students under the age of 18.
- Students could earn grades for their college coursework that negatively impact <u>both</u> their college and high school grade point averages.
- Students who withdraw from or fail college classes could be required to reimburse their high schools for the cost of these classes, to include textbooks.

University of Cincinnati:

Benefits

- Students could take classes at the college that are not offered at their high school.
- Students could 'survey' a variety of college disciplines before they must make a final decision about pursuing either a college education or a particular college major.
- By taking college classes for which they will receive both high school and college credit, students could reduce the time needed to complete their eventual college degree.
- By taking college classes without paying for any of the costs associated with these classes, students could reduce the overall cost of their eventual college degree.

Ohio students participating in dual credit programs graduate from high school at higher rates,
persist through postsecondary education at higher rates and in less time, and maintain above

CCP Guidelines: UC CLERMONT COLLEGE (UCC)

In addition to the guidelines established by the Ohio Department of Higher Education, CCP participants must also satisfy the academic and admission requirements established by UC Clermont College.

ACADEMIC REQUIREMENTS	
Matriculation Requirements	CCP students must enroll at UC Clermont as non- matriculated HIGH SCHOOL students. If students wish to attend UC Clermont after they graduate from high school, they must complete UC Clermont's <u>college</u> admission and matriculation process.
Learning Requirements	CCP students must assume responsibility for their own learning. If students experience academic difficulty, they must proactively seek assistance from both their instructors and UCC's <i>Academic Success</i> <i>Center</i> . They should also discuss the situation with their high school guidance counselor.
Attendance Requirements	CCP students must follow the attendance policies established by the instructors for the courses in which they enroll.
	<u>Note</u> : Students must attend their UC Clermont classes even when these classes conflict with high school breaks, holidays, and extracurricular activities.
Course Requirements	Typically, CCP students should register for 1000 and 2000 level courses for which they have satisfied all pre- requisites . <u>Note</u> : UC Clermont reserves the right to limit the number and type of courses available to CCP students.
GPA Requirements	CCP students must maintain BOTH a semester and cumulative GPA of at least 2.00 (on a 4.00 scale) for EACH semester they are enrolled at UC Clermont. Failure to do so may result in their dismissal from CCP.
'Student Conduct' Requirements	CCP students must comport themselves according to the guidelines established by UC Clermont's <i>Student Code of Conduct</i> . CCP students who violate these guidelines are subject to the same disciplinary actions as any other UC Clermont student. <u>http://www.uc.edu/conduct/Code_of_Conduct.html</u>
High School Graduation Requirements	CCP students are responsible for both knowing and meeting their high school graduation requirements. Toward this end, students must meet regularly with their high school guidance counselor.

SELECTING CLASSES

For CCP students, the course selection process is a function of both the classes required by their secondary schools for high school graduation and the classes required by the University of Cincinnati for the major they plan to pursue after high school graduation. Students must work with their high school guidance counselor to determine the former and refer to the appropriate UC curriculum guide to determine the latter.

The random completion of college courses does NOT a degree make. To earn a college degree, students must complete the <u>specific</u> courses required for a <u>particular</u> major (as detailed by the major's curriculum guide).

Curriculum Guides

Curriculum guides list all of the classes that a student must take in order to complete a particular major at the University of Cincinnati.



Course Options

UC Clermont offers hundreds of courses each academic year. The following is a list of the courses that seem to be of particular interest to CCP students.

English Composition

English 1001 and 2089 are the only courses required for ALL majors at UC.

- ► ENGL 1001 English Composition -- a 1st first year foundations course
- ► ENGL 2089 <u>Intermediate Composition a 2nd year capstone course (pre-req: 30 credit hours)</u>

CCP students may NOT take remedial composition courses, e.g., ENGL 0097, 0099 or 1000.

Foreign Language

UCC offers the following foreign language courses: American Sign Language, French, German, Russian, and Spanish. Students may take these courses in either an extended or basic format:

- extended: <u>3</u> semester hours per course: <u>12</u> semester hours total (preferred by most students)
- ▶ basic: <u>5</u> semester hours per course: <u>10</u> semester hours total (intense)

Mathematics & Science

The Math and Science courses that students take at UC Clermont are a function of both their ACT or MPT results and their intended college major. For specifics, students should refer to the curriculum guide for the major they plan to pursue on the college level.

CCP students may NOT take remedial Math courses, e.g., MATH 0030, 0031 or 0034.

Personal Finance

The following course should satisfy the personal finance requirement for high school graduation. However, before registering for the course, students should discuss this option with their high school guidance counselor.

► FIN 2081 Personal Finance

Political Science (American Government)

The following course should satisfy the American Government requirement for high school graduation. However, before registering for the course, students should discuss this option with their high school guidance counselor.

▶ POL 1010 Introduction to American Politics

You must take ALL of your classes at UC Clermont, including your <u>online</u> classes.

ACADEMIC ADVISING

High School

For advising related to high school policies and procedures, to include high school graduation requirements, CCP students must contact their high school guidance counselor.

College

For advising related to college policies and procedures, to include the course requirements for particular college majors, CCP students should contact Dr. Debra Clark at <u>debra.clark@uc.edu</u>

High School Graduation: COURSE SUBSTITUTION CROSSWALK

This information includes general guidelines about college courses that can be substitutions for high school requirements. The list does not include all possible examples of courses. All course substitutions must be nonremedial and nonreligious. Students must earn passing grades in the courses. The required credits noted within this document are the minimum required for high school graduation. Some school districts might have additional credit requirements for graduation. This document describes College Credit Plus as one option for satisfying high school graduation requirements; refer to other Ohio Department of Education guidance for other options (e.g., credit flex, physical education waiver).

Physical Education (1/2 high school credit)	Courses in which the main concentration is participation in physical activity, fitness, and/or exercise.	
Science (3 high school credits)	Any science courses	 Students must earn: one unit of physical sciences, one unit of life sciences and one unit of advanced* study in one or more of the following sciences: chemistry, physics or other physical science; advanced biology or other life science; astronomy, physical geology or other earth or space science (*Note: A CCP science course does satisfy the advanced study requirement.) Schools must administer the biology EOC test to all students in order to satisfy federal testing requirements. CCP students may use their course grades and AP/IB students may use their test scores OR the biology end-of-course test score to earn graduation points, whichever is higher.

Courses that CCP students may NOT take on the college-level:

- ► Study abroad courses.
- ► Courses with fees that exceed the maximum amount established by the Chancellor.
- ► Physical education courses.
- ► Remedial and (sectarian) religion courses.
- Courses that provide P/F or S/U grades only. Exceptions: Internships or 1st year academic/career success courses.

'ON-CAMPUS' CCP (includes both 'in person' and 'online' courses)

To participate in UC Clermont's 'on campus' CCP program, interested students must submit an online CCP application and the requisite ACT or SAT test scores (see below).

1) high school juniors may take a <u>free</u> ACT test at their high school, and 2) economically disadvantaged students may request an ACT/SAT fee waiver from their HS guidance counselor.

The minimum test scores identified above are for **CCP admission purposes only**. Students must still satisfy the test score **pre-requisites** for each course in which they wish to enroll – <u>many</u> of which are higher than those required for CCP admission.

'ON-CAMPUS' and 'IN HIGH SCHOOL' CCP

To participate in <u>both</u> UC Clermont's 'on campus' <u>and</u> 'in high school' CCP programs, interested students must satisfy the admission requirements for the 'on campus' program (see above).

'IN HIGH SCHOOL' CCP

To participate in UC Clermont's 'in high school' CCP program, interested students must submit an online CCP application. They must also work with their guidance counselors to take the required placement tests and register for the appropriate course(s).

AP and College Credit: If you want UC to evaluate either AP or college credit (earned elsewhere), you must contact the College Board (AP) or the college you previously attended and ask them to send <u>official</u> test scores or transcripts to UC directly. The AP/transcript evaluation process can take 4-6 weeks (longer during peak times). Please plan accordingly.

Summer Classes: Given both the early start date (*first week of May*) and the accelerated pace of most summer classes, this option is **appropriate for current CCP students only.** <u>Note</u>: Classes completed during the summer are counted toward the CCP maximum of 30 hours.

AP and College Credit: If you want UC to evaluate either AP or college credit (earned elsewhere), you must contact the College Board (AP) or the college you previously attended and ask them to send <u>official</u> test scores or transcripts to UC directly. Online CCP Application: 'NEW' APPLICANTS

HELPFUL HINTS

If you have NOT taken an 'on campus' or 'in high school' class previously as a CCP student at UC Clermont, UC Blue Ash or UC Uptown, you must submit a CCP application for 'new' students.

Instructions:

- Choose College Credit Plus as your application.
- Provide an email address that you can check easily for a <u>temporary PIN</u> that will be auto-emailed to you. Note: The security protocols at some high schools are blocking this email. You may need to complete your application at home.
- Do NOT submit a *CCP Authorization Form*. This form is required for UC Blue Ash and UC Uptown only. As long as you've submitted an *Intent to Participate Form* to your high school (or ODHE), you're 'authorized' to participate in UC Clermont's CCP program.
- After submitting your application, <u>"Check Your Status</u>" regularly.

Note: The CCP Authorization form is **required** for UC Blue Ash and UC Uptown CCP applicants. It is **optional** for UC Clermont CCP applicants.
